In consideration of being allowed to participate in the activities of training or instructional classes and my child or children (if accompanied by a child or children), and to my property during any activity or shoot held by **Victory Ranch**, whether self-inflicted or inflicted by others and whether or not the acts of others were intentional or negligent. In no case shall I hold **Victory Ranch** responsible for the acts of third persons who may injure myself, my child or children or my property. I understand there will be **NO** drugs or alcohol permitted on the property of Victory Ranch and that there are rules and regulations put in place to maintain the safety of myself and others. I also understand that **RAPID FIRE is NOT PERMITTED**. I agree that I will follow **ALL** rules. I also understand and agree that if any of the property owned by **Victory Ranch** are damaged by me whether intentionally or negligently, I may be held liable for the cost of the item(s) damaged. I execute this waiver, consent, and release on my own behalf and on behalf of my child or children, if they are accompanying me, realizing that this sport is not hazard-free and fully assuming those risks of all conditions in and about the activity area. I also waive any and all specific notice of the existence of any hazards. I freely and voluntarily assume all risks associated with the use of the private range and agree that **I AM SHOOTING AT MY OWN RISK**.

By becoming a member, I am implying that I have read, understand, and agree to **ALL** terms, rules, membership fees & policies of Victory Ranch. I agree to pay the full dollar amount of any and all memberships that I have agreed to. Furthermore, I understand that failure to adhere to all rules, terms, conditions & policies may constitute a breach of member agreement. If there is a breach of member agreement members will still owe any dollar amount not fully paid for. For any fees unpaid Alternative collection methods will be considered. Membership fees in Victory Ranch do not purchase rights, only privileges. There are no guarantees for time or duration. Any behavior deemed detrimental to the reputation, safety, or operations of Victory Ranch members may have memberships revoked at any time. No refunds of any kind will be issued

Private Shooting Hours 0900-1400 (9am-2pm)

**All members and guests who enter**

**MUST CHECK IN & OUT EVERYTIME!**

**EVERYONE, EVEN IF IN SAME VEHICLE MUST  
include first and last name as well as whether you are entering or leaving  
the range.**

- 1. Check in instructions EXAMPLE “Jon Doe entering the range”**
- 2. Check out instructions EXAMPLE “Jon Doe leaving the range”**

**911 will be called for any individuals who fail to check in.

## **MUST READ AND OBEY ALL RULES / REGULATIONS**

(Additional rules may be implemented as needed)

1. You must obey ALL private range rules.
2. Conduct deemed detrimental to the reputation, safety, or operations of Victory Ranch Gun Range will not be allowed
3. Everyone on the property must have authorized access
4. Ear & eye protection REQUIRED.
5. Any chat groups set up by Victory Ranch Gun Range may be moderated to keep content relevant and family friendly.
6. ONE day members are to shoot at paper targets only. Unless stated otherwise.
7. All Membership fees must be paid prior to arriving or taking your first shot on the gun range. Members paying by installment must be current.
8. Every member should understand that this is a private range. There are rules to maintain everyone's safety. But understand that you are shooting at YOUR OWN RISK.
9. Fines or revocation for negligence. Negligence will not be tolerated.
10. Do not participate in any shooting events or training above what you can do safely and proficiently.
11. ALL firearms need to be holstered, cased, or in a range bag prior to shooting. And when finished shooting needs to be re-holstered, cased, or put back into the range bag.
12. Keep muzzles pointed downrange, or in a SAFE direction always.
13. Keep your finger off the trigger until you are ready to shoot.
14. Do not step past the firing line until ALL shooters have been made aware the range is COLD.
15. Before firing shooters are to check surroundings and announce GOING HOT.
16. Safely moving and shooting is only done in permitted areas ONLY!
17. Pick up your trash. EX: plastic, paper, bottles etc.
18. When you are not shooting. Firearms should have a chamber flag or have the slide/ejection port/action in a locked open position.
19. Members or those with authorized access on the property ONLY. Non authorized access will be asked to leave or be charged with TRESPASSING!
20. Controlled burst fire ONLY.
21. ALL shooting & gun handling done on the premises should be SAFE. Reckless gun handling and or shooting you will be dismissed or possibly charged with endangerment!
22. Rifle calibers minimum of 75 yards at steel targets. (No green tip, or any armor piercing bullets to be shot at steel. PAPER TARGETS ONLY!)
23. No ammunition of any kind that is a fire hazard. Tracers, dragon breath etc.
24. No explosives (ied's, grenades, flash bangs, tannerite etc.)
25. Magnum rifle calibers minimum distance on steel 150 yards or paper targets only. Unless permission is stated otherwise from the property owner.
26. Handgun calibers minimum of 10 yards on steel.
27. Before shooting further distances with rifles, always verify it is zeroed by confirming at 25 or 50 yards.

28. Shooting is done from permitted areas only

## • Refund & Cancellation Policies

### **No cash back refunds are permitted**

Membership fees are a fully due one-time payment but for your convenience you may elect to pay the membership fee in twelve (12) equal monthly installments. By enrolling you accept full responsibility for the full membership fee, which you understand will remain due and payable regardless of whether you continue to utilize membership privileges or cancel before completing all installment payments. Membership fees must be paid promptly and in full. Upon nonpayment the total fee will still be fully due & will be subject to collection.

## • Training Courses / Competitions

A good amount of time, expenses and work goes into setting up these events, courses and competitions. Once you have paid you have committed. So, show up!

### • Bad Weather / Unforeseeable events

If a course is cancelled due to some unforeseeable event... Most likely bad weather. All courses affected will be rescheduled.

### • 30 Day Reschedule Policy

If you have signed up for a training course and cannot make it for ANY reason, your course may be rescheduled. You will have 1 month (30 days) from the initial course to take the next course available. If you have decided not to take the course at all you will forfeit all funds.

### • Private Range Membership & Fees

This outdoor shooting range is a private facility that exists solely for the enjoyment of its members, their guests, and individuals who complete a sign-up process. We are not a public range, and we do not accept walk-in visitors. All access is restricted to members in good standing, approved guests and signups.

Membership fees in Victory Ranch Gun Range are based on a one-time fee which grants current private access and privileges of membership. There are no guarantees of time or duration being purchased. So, long as the member adheres to all rules and policies membership privileges may continue and will renew automatically.

## ● Automatic Renewal / Cancellation by Payment Only

I understand that I am shooting at my own risk, and I voluntarily assume all risks associated with the use of the range's facility.

I ACKNOWLEDGE & FULLY UNDERSTAND\*

- **WAIVER, RELEASE & CONSENT**

I hereby release, discharge and agree not to sue Victory Ranch Gun Range, its owner(s) officer(s), employee(s), Volunteer(s) or affiliates from any and all liability, claims, demands, or causes of action arising out of or related to my participation in shooting activities, whether caused by negligence of the released parties or otherwise.

I CONSENT\*

- **MEMBERSHIP PRIVILEGES**

I UNDERSTAND this agreement is for current private membership privileges and ongoing access only. There are no rights, time guarantee's, or guarantees of future privileges or access therefore it does not constitute a prepaid entertainment or sports contract under (NC GS 66-118)

I UNDERSTAND\*

- **INDEMNIFICATION (COMPENSATE)**

I AGREE to indemnify, defend, and hold harmless the released parties from any loss, liability, damage, or cost (including attorney fees or court fees) arising from my presence at or use of the club facilities, whether caused by negligence or others.

I AGREE\*

- **SAFETY & RULES**

I AGREE to follow all posted and communicated rules, and the direction of club staff. I understand that failure to comply may result in immediate removal from the premises and revocation of membership or privileges without refund

I AGREE\*

- **SEVERABILITY**

If any provision of this agreement is found invalid or unenforceable, the remainder shall remain in full force and effect.

**MISCELLANEOUS**

- This agreement constitutes the entire understanding between the parties and supersedes all prior agreements
- The club reserves the rights to amend its policies, rules, and membership fee rates.
- This agreement shall be governed by laws of the state of North Carolina
- **DISPUTE RESOLUTION - BINDING ARBITRATION**

The Member and Victory Ranch agree that any dispute, claim, or controversy arising out of or relating to this Membership Agreement, the use of Club facilities, or participation in Club activities shall be resolved exclusively by binding arbitration. The arbitration shall be conducted in Wayne County, North Carolina, before a single arbitrator, in accordance with the rules of the American Arbitration Association (AAA) or another mutually agreed-upon arbitration provider.

The parties agree that the arbitrator's decision shall be final and binding, and judgment on the award may be entered in any court of competent jurisdiction. Each party shall bear its own attorneys' fees and costs, except as otherwise awarded by the arbitrator.

The Member understands and agrees that by signing this Agreement, they are waiving the right to a trial by jury or to participate in a lawsuit regarding any dispute covered by this clause.

# RANGE 1

**(Ranges may look different in person due to constant updates)**

- 25 - 100 yard distances
  - Barrels can be used as tables to place firearms on as well as to create barriers for training scenarios.
  - **All guests must shoot on this range (no exceptions)**
  - Rifles, pistols shotguns allowed on this range
  - Controlled rapid fire permitted this range ONLY!
  - Safe movements allowed
- (Must refer to rule book for complete range rules and regulations)





# RANGE 2

**(Ranges may look different in person due to constant updates)**

- Dedicated sporting clay range
- 3 automatic clay throwers.
- Throwing patterns are left crossing, right crossing, straight ahead
- ONLY shotguns are allowed on this range
- Single shots & birdshot loads only at this range.
- Firing line shooting only.

(Must refer to rule book for complete range rules and regulations)





# TEXAS STAR PIT

- Minimum 10 yards shooting distance
  - ONLY pistols and shotgun calibers are allowed on this target
  - NO RIFLES OR RIFLE CALIBERS in this area
  - Must reset targets after usage
- (Must refer to rule book for complete range rules and regulations)



# RANGE 3

**(Ranges may look different in person due to constant updates)**

- 150-yard range
  - Barrels can be used as tables to place firearms on as well as to create barriers for training scenarios.
  - Rifles, pistols shotguns allowed on this range
  - Controlled rapid fire permitted this range ONLY!
  - Safe movements allowed
- (Must refer to rule book for complete range rules and regulations)



# RANGE 4

(Ranges may look different in person due to constant updates)

- 35-yard range
  - Pistols & Shotguns only!
  - NO RIFLES at this range. Immediate revocation!
  - Shots from firing line only.
  - Single shots & controlled bursts only.
- (Must refer to rule book for complete range rules and regulations)



# RANGE 5

**(Ranges may look different in person due to constant updates)**

- 300/400-yard rifle range
- Steel targets are preset downrange 18"x24" gong, 6" popper, 5" popper
- Rifles, pistols shotguns allowed on this range
- Single shots only.
- No burst fire. No mag dumps.
- Shoot from firing line & benches only.
- No .50 BMG.
- No armor piercing bullets,
- No fire hazard ammunition

(Must refer to rule book for complete range rules and regulations)
